Meeting was called to order by Jim Donze @ 7:00 p.m.

Announcements

- We would like to thanks all our Veterans for their service to our country and also to the many volunteers who help make our community a wonderful place to live!
- Our secretary, Mary Joggerst, will be retiring at the end of the year. Mary has been with LFE for 25 years. Many thanks to Mary for all she has done and her many years working here, she will be missed.

Open Forum:

- A resident asked about putting a sign at their driveway stating it is a private drive in hopes of deterring the many vehicles (including UPS) from turning around in their driveway. It would be an attractive, tastefully done, professionally manufactured sign.
 - The board approved this type of sign due to it not being an advertisement or a sign of personal opinion, it would be considered much like the address signs.
- A resident asked about parking their work pick-up truck along the side of their house if they were able to cover the work logo's in a visually appealing manor. The pick-up does not fit in their garage and they have approval from their neighbors.
 - The board approved this.
 - Also, was discussed that some of these discrepancies between the blue and greens books have been clarified in the books being re-printed currently.

Business Session

Approval of Minutes:

 Motion to approve the October minutes was made by Harry Davis. Seconded by Dave Evelsizer. Motion passed with all in favor.

Treasurers Report: Bob Palmer

- As of October 31, 2017, we had \$216,928 in our checking accounts and \$337,897 in certificates of deposit. Our outstanding loan balance was \$423,955.
- For our fiscal year to date, our total income was \$400,708 and our expenses were \$251,990, resulting in net income of \$148,718. We currently have \$19,163 in outstanding assessments for this year. Most of this is from assessments that are paid quarterly and will be paid in December.
- Motion to approve the treasurers report was made by Greg Stephenson. Seconded by Dave Evelsizer. Motion passed with all in favor.

Community Managers Report: Tom Duro

- Water Usage Well #1 pumped 1,271,000 gallons and well #2 pumped 1,210,600 gallons for a total of 2,481,600 gallons of water. Both wells running good. We will be working on all 3 well buildings updating soffits, paint, cleaning up some old wiring.
- Lagoon John & Wayne Basler replaced 24 pair of flotation devices for the dividing curtain. Still need about 20 plus or more pair to complete. Thank you Wayne and John. Kaeser Compressor came out and replaced oil seals on both compressors. One seal held the failed after about 4 days. Kaeser will be back to replace. Cost to replace 2 seals and service call \$1756.31.
- Maintenance I have been busy this month getting boat shed area ready for buildings and trailer parking. Removed a dead tree at the entrance. Closed and winterized all restrooms outside at Community Center. So only restroom s open are at the Marina. The new Lake Forest Community Center/office sign has been installed. Braced up the pavilion below basketball court area. Removed tree outside office. Had all fire extinguishers replaced by Cintas, about \$376.93 for 6. The ones we had were from 2006 and 2009 since checked.

 - Motion to approve made by Bob Palmer. Seconded by Greg Stephenson.

Committees:

Public Works/Road/Water/Sewer/Lagoon: Don Kuehn

- There are some cracks to be sealed and the issue on Tall Pine to be taken care of.
- The Multipurpose lights on timer are being addressed and options looked at.
- Sealing is still needed on the court area.
- A question was asked regarding the repairs needed on the bridge at marina.
 - This is planned to be done after the boating season, sometime this fall. Will be done this year.
 - It was mentioned that a ground hog is living in there and that it is deteriorating more.

Planning and Finance: Bob Palmer

- We are starting the budget process and have requested budgets from various committees. We need to decide what to do with that.
- We are shooting for a committee meeting Thanksgiving week or the week after that.
- It should be ready by the December meeting for approval.

Lakes: Duane Harley

- The damaged security post down by the marina has been repaired this past weekend. An additional 120 pounds of concrete along with additional rebar was added.
- Inner tubes will go on buoys this weekend.
- The Lakes Committee 2018 budget has been submitted for review and consideration. Lake fish stocking and paint/supplies added to the budget to re-paint picnic tables. The grills down at the marina are in bad shape and the bottoms need re-welded or replaced. We understand Tom Duro is already aware of this issue.
 - o Tom replaced with the one from the community center.
- A Lake Forest resident suggested to the Lakes Committee that those individuals that currently have boat slips are offered the first opportunity for renewal. Last year she stated that she was the first one in line for the office to open and when she reserved her slip, she was told a few had already been reserved ahead of her. I did tell the individual that we are considering adding additional boat slips in the future.
 - Boat slips will still be on first come first serve basis on or after February 1st in person at the office NO DROP BOX NO PHONE CALLS

As a courtesy reminder, the combination to the locks will be changed on January
 1st. The new combination will be re-issued when owners get their annual boat stickers.

Question to the Board:

- Can the existing slips be reconfigured to accommodate more slips?
 - Not really due to the concrete and other configuration issues.
- Increasing the cost per slip has been discussed, no determination has been made at this time.
- May add additional slips next year.
- A resident has had some items stolen off his boat at the marina this year, paddles, seat covers etc.

 - Equipment etc. may go under other budgets. Currently there is \$750 for tables budgeted.

 - The photographer does not live here so the resident would have to reserve the Marina Pavilion and take responsibility for the event.

Boatsheds:

- Work is in progress. 15 are being built. There are two (2) units available, 26ft x 12ft with 11ft wide x 10ft high doors. Pricing is similar to what was discussed prior. Contact the office if interested and for pricing.

- We are increasing the area for the trailers etc. Letters to be sent out regarding parking trailers.
